

# 2019 SSJRTC MEMBERSHIP APPLICATION/ AGREEMENT

## Sunshine State Jack Russell Terrier Club Membership

The Sunshine State Jack Russell Terrier Club (SSJRTC) is currently the only JRTCA affiliated club located in Florida. The primary purpose of the SSJRTC is to educate people about Jack Russell Terriers, to be a group that has fun with our terriers, and to preserve and work our terriers. Also, to protect, maintain and promote (for educational purposes) the acceptable breed standard of the Jack Russell Terrier. SSJRTC membership includes discount entry fees at sanctioned & non-sanctioned SSJRTC events, SSJRTC voting privileges, and free practice/ training sessions of performance trial events.

### 2019 Membership Agreement & Application

Persons applying for membership in the SSJRTC (new or renewing a current membership) and members of their immediate family must not be a member of a conflicting JRT organization as defined by the JRTCA; conflicting organizations include any organization promoting kennel club recognition/registration of the JRT. Membership may be terminated, suspended, or refused by the SSJRTC Board of Directors for any conduct, which may be considered likely to prejudice or damage the image of or interfere with the efficient running of the SSJRTC, or compromise the breed in any way. I hereby apply for membership in the Sunshine State Jack Russell Terrier Club. I agree to abide by the objectives and purposes stated by the SSJRTC, and certify that I do not belong to a conflicting JRT organization, nor do I register my JRT with any kennel club. I hereby waive any and all claims for, and remise and release the club, its members, officers, directors, and agents, and all animals, animal owners, spectators, and any other participant from any and all liability for participation in any activities including the period of time immediately prior thereto and immediately thereafter the conclusion of the activity. The signer(s) understands that by participating he or she is a joint venture participant and assumes all the risk of and liability for injury to themselves occasioned by this participant. I understand that there is a service charge on refunded checks. This agreement shall be effective from the date of signing. **I also understand that it is my responsibility to keep my contact information current with the club.**
